BACKGROUND

1. The Fifty-seventh session of the Regional Committee requested the Secretariat to provide regular updates to Member States on progress achieved in strengthening compliance with administrative rules, regulations, policies and procedures. The purpose of this document is to inform Members States about achievements and challenges in the areas of accountability, audit and risk management since the Sixty-ninth session of the Regional Committee.

2. The document builds on a substantive report submitted by the Secretariat to the Sixty-eighth session of the Regional Committee. The report documents the accomplishments and challenges of the Accountability and Internal Control Strengthening (AICS) project that was launched in 2015 to promote the goals of the Transformation Agenda. The AICS project has achieved significant progress in advancing a culture of accountability and strengthening of internal controls in the African Region, particularly in country offices. The reporting period for this document is the year from March 2019 to February 2020.

EXTERNAL AND INTERNAL AUDITS

3. During the reporting period, four internal audit reports were issued for the following budget centres: South Sudar; Mozambique; Democratic Republic of the Congo, which included the emergency response to the Ebola virus disease outbreak; and the Central African Republic. The internal audits issued during the reporting period were rated as partially satisfactory with some improvements required (one audit) or major improvements needed (three audits), reflecting the general improvements in the internal control environment in the Africa Region.

4. Two external audits were issued for the Country Offices in Nigeria and Uganda. The external audit of the Regional office for Africa was suspended in March 2020.

5. Prompt and effective implementation of audits remains a management priority. The progress in implementing audit recommendations is reported quarterly to the Regional Compliance and Risk Management Committee (CRMC). The more holistic approach adopted to address control gaps in a comprehensive manner has enabled effective solutions for common problems in the Region. As a result, three internal audits¹ and four external audits² were successfully closed; 60% of the total audit recommendations were successfully closed; with 40% outstanding. Annex 1 shows the detailed status of the implementation of audit recommendations.

MANAGERIAL KEY PERFORMANCE INDICATORS (KPIs)

6. The Regional Office continues to regularly monitor the performance of budget centres against the 17 (seventeen) established managerial key performance indicators (KPIs) covering the enabling functions: finance, procurement, human resources management (HRM), security, information technology (IT), travel and asset management. During the year under review, there were notable improvements in the areas of DFC and direct implementation, asset management and human resources, objective setting and performance reviews. There was a decline in the ratio of international travel bookings made at least 14 days before the travel date.

7. Performance results have been regularly reported to the CRMC and shared with budget centres and through KPI dashboards, to document past performance results and inform the implementation of recommended actions as needed. The Regional Office provides analyses and guidance to budget centres to address the causes of any downward trends in performance. A ranking of budget centres was established for greater transparency. The three best performing WHO country offices for the reporting period in the various categories are presented in Table 1.

RISK MANAGEMENT

8. All budget centres in the WHO African Region continue to manage their risks using a corporate risk management tool. The local risk registers contain risks and related risk mitigation plans. This consistent and coherent methodology and approach is enabling more effective decision-making to improve delivery of results and embed risk management in operational processes, both in the results-based management cycle (planning, performance assessment and budgeting) and in the accountability and internal control frameworks.

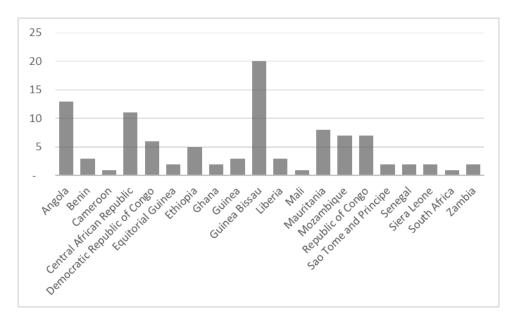
9. During the end of biennium assessment of Programme budget 2018-2019 implementation, all risk registers were updated, with 240 risks documented. Mitigation plans have been developed for 181 risks, as shown in Table 2 below:

DIRECT FINANCIAL COOPERATION (DFC)

10. Close attention continues to be paid to DFC reports, with rigorous and systematic monitoring by WHO country offices and the Regional Office. In the reporting period, the number of outstanding reports increased slightly compared to previous years. As of February 2020, there were 101 overdue DFC reports totalling US\$ 7.5 million, compared to 44 overdue DFC reports totalling US\$ 8.5 million in February 2019. The chart below presents a summary of the number of overdue DFC reports by country. Annex 2 lists the number of overdue DFC reports by country and the respective unjustified amounts.

11. The regional framework for accountability and assurance activities operationalizes the relevant provisions on accountability and assurance activities as prescribed in WHO policies. A specialist team continues to provide DFC, DI and grant letter of agreement (LoA) assurance services throughout the Region. The team visited 12 countries³ in the year to February 2020 with combined DFC expenditures of US\$ 44 million (representing 52% of DFC expenditure in 2019). Specific weaknesses identified during these missions were discussed with implementing partners and WHO country office staff to enhance their capacity and improve their ability to comply with the DFC standard operating procedures (SOPs), including timely reporting.

12. Member States are expected to fully collaborate with the WHO Regional Office and country offices and facilitate the effective implementation of the DFC accountability and assurance framework. Member States are also requested to expedite the submission of the outstanding DFC reports.

13. The Regional Committee noted this report.
