









5. Annual average rate of reduction: 2010-2017 vs 2010-2030

Reproductive Maternal Health & Ageing(RMH) Contraceptive prevalence - Modern Methods: Percentage of women of reproductive age who are using (or whose partner is

using) a modern contraceptive method at a particular point in time

Unmet need: percentage of fecund women of reproductive age who want no more children or to postpone having the next child, but are not using a contraceptive method, plus women who are currently using a traditional method of family planning FP - Family planning, MMR - Maternal Mortality Ratio
