### DRAFT PROVISIONAL AGENDA, PLACE AND DATES OF THE SEVENTY-SECOND SESSION OF THE REGIONAL COMMITTEE

1. In accordance with Rule 4 of the Rules of Procedure of the Regional Committee, the Regional Director presents the following proposal on the place and dates for the Seventy-second session of the Regional Committee:

2. By virtue of resolution AFR/RC41/R13, the additional costs of hosting the Regional Committee in a country other than that of the Regional Office shall be fully borne by the host country. Should a Member State be interested in hosting the Regional Committee, an agreement is drawn up between the host country's government and the World Health Organization, covering the following items required for the Regional Committee meeting:

- (a) Premises, furniture and equipment, including interpretation equipment required for the Regional Committee's work;
- (b) Lighting equipment, including maintenance, electric power supply and ventilation of the premises;
- (c) Staff for maintenance, cleaning and surveillance of the premises, installations, equipment and supplies;
- (d) Postal and telephone service, together with radio and television coverage essential for the efficient and proper coverage of the Regional Committee's proceedings;
- (e) Accommodation and travel expenses for the WHO Secretariat authorized to attend the meeting;
- (f) Vehicles for transporting Member State representatives, members of the WHO Secretariat, equipment, supplies and documents; national currency at the best rate of exchange and in the amount needed to meet the Organization's expenses in the host country.

3. The Regional Director deems it expedient to draw the attention of Member States to the need to give full consideration to these commitments.

4. Any Member State that wishes to host the Seventy-second session of the Regional Committee should express its interest during the consideration of this agenda item. In the event that there is no expression of interest from any Member State, the Regional Director proposes that the Regional Committee be held in the WHO Regional Office for Africa. It is further proposed that the Seventy-second session of the Regional Committee be held from 22 to 26 August 2022. The draft provisional agenda is attached herewith.
