## WORKING DOCUMENT STRATEGIC BUDGET SPACE ALLOCATION

## **Operational segments**

- 1. In document EB134/10, in which the Secretariat proposed a new strategic budget space allocation methodology, WHO's work was divided into four broad operational segments:
  - (i) individual country technical cooperation;
  - (ii) provision of global and regional public goods;
  - (iii) administration and management functions;
  - (iv) response to emergency events such as outbreak and crisis response.
- 2. The present document describes each of these operational segments and lists some key functions and roles of the three levels of the Organization (see Table). The main sources used are the report of the Taskforce on the overarching roles and functions of the three levels of WHO<sup>2</sup> and the report on financing of administration and management costs, submitted by the Secretariat to the Executive Board at its 134th session.<sup>3</sup>
- 3. In respect of the fourth segment (response to emergency events such as outbreak and crisis response), the *Emergency Response Framework*<sup>4</sup> provides additional information in a detailed description that is limited to WHO's critical functions and the associated role of the three levels of the Organization.

In line with a recommendation of the Programme, Budget and Administration Committee at its twentieth meeting, contained in document A67/9, references to "strategic resource allocation" have been changed to "strategic budget space allocation".
