## The 67<sup>th</sup> Session of the WHO Regional Committee for Africa Opens in Victoria Falls

The 67<sup>th</sup> session of the WHO Regional Committee for Africa opens today in Victoria Falls, Republic of Zimbabwe. The 47 Member State WHO Governing Body will run from 28<sup>th</sup> August to 1<sup>st</sup> September 2017 at the Elephant Hills Hotel.

During the meeting, the WHO Regional Director for Africa will present a report on the work of WHO in the Region for 2016 to 2017 followed by a draft concept note on the WHO Thirteenth General Programme of Work. The delegates will review the five-year draft global strategic plan to improve public health preparedness and response followed by a report on the implementation of the Transformation Agenda.

Two regional strategies on the Management of Environmental Determinants of Human Health and on Sexually Transmitted Infections will be presented and discussed. In addition, four implementation frameworks on the elimination of yellow fever, health system development towards Universal Health Coverage, human resources for RC67 e-Journal : Day 1

achieve Universal Health Coverage (UHC) for the people of Africa.

The continent continues to experience several public health challenges including Ebola, dengue fever, Lassa fever, meningitis, yellow fever cholera outbreaks and natural disasters such as flooding. I am glad to report, that due to the increased preparedness in member states and in WHO, these outbreaks and emergencies have been effectively tackled wherever they occur. The burden of communicable diseases remains high, antimicrobial resistance is spreading and Non Communicable Diseases are increasing exponentially. Broad determinants of health such as climate change, poverty and governance are posing new public health challenges especially for vulnerable populations.

We are determined to support member states to address these and other challenges by taking advantage of the attention and platform provided by the Sustainable Development Goals and the new communication technologies to advance UHC in Africa. We pledge to support Member States by providing policy advice, developing capacities for health, shaping partnerships and building resilient health systems among others.

The transformation Agenda (2015-2020) to make WHO in the African Region effective, responsive and accountable continues to be implemented in the Regional and country offices. The functional review exercise has been completed in the Regional Office and 18 countries will be completed by the end of 2017. Five countries, i.e. Senegal, Sierra Leone, South Africa and South Sudan have already begun the process.

This year, the daily Regional Committee Journal will be provided to delegates electronically on smart phones, computers, iPads or any other mobile devices. Limited printed copies will be available for delegates who may need them. The WHO Secretariat is at your disposal for any assistance needed during this session.

I wish you a successful meeting.

#### WHO develops a new five-year overarching public health Programme

The World Health Organization (WHO) has commenced on the process to develop its Thirteenth General Programme of work (GPW) that will run from 2019 to 2023.



The process takes into account events such as recurrent pandemics, conflicts, natural disasters, climate change and epidemiological transition which negatively impact the health of the world's population and require more effective approaches to global public health management.

The eJournal can be accessed from all electronic This, together with the unfinished agenda of the Millennium Development Goals and the expectations of the Sustainable Development Goals (SDGs) calls for an effective global public health organization strategically positioned to provide evidence-based and foresighted support to countries.

The GPW will aim at ensuring greater harmonization and coherence in the organization's work across its three levels and will be the strategic framework for its 2020/2021 and 2022/2023 programme budgets and the basis for resource mobilization. In short, the GPW will define what the organization will do differently in the coming years.

For instance, the programme will put more emphasis on demonstrating the outcomes and impacts of the organization's work rather than outputs, serve as a flagship for driving its SDG agenda and set leadership priorities which will be reflected in its plans and budgets. Furthermore, the programme will outline strategies aimed at making WHO more operational especially in fragile, conflicted affected and vulnerable states while at the same time strengthening its normative functions, highlight opportunities for improving the global health capacity and political leadership of the organization and put more emphasis on ensuring that its Member States are central to its work.

Four main strategic priorities are being proposed in the new GPW : 1) prevention and control of public health emergencies and disasters; 2) Universal Health Coverage for the world's population; 3) attainment of the health related SDGs especially in the areas of adolescent, maternal and child health, climate and environmental change, communicable and non-communicable diseases; 4) inclusive public health decision making.

Internal and external consultations are already underway as part of the GPW development

process. The 67<sup>th</sup> Session of the WHO Regional Committee for Africa provides a unique opportunity for African Members States to contribute to the finalization of the Thirteenth GPW. It is hoped the programme will be finalized and approved by the World Health Assembly in May 2018. RC67 e-Journal : Day 1
